

Appendix F – About the Writer – Carman Bradley

Gill (my wife of 40 years - 1978) and I have three daughters, a son-in-law, and a granddaughter in the family. My formal education includes Civil Engineering and Masters of War Studies degrees from Royal Military College, and a MBA from Queen's University, Kingston. I am a Canadian Forces veteran. I taught Business Operations at DeVry Institute of Technology, Calgary Campus, for ten years. Presently, I work as a Business Management Consultant based out of Calgary.

I surrendered my will to Jesus Christ during an evening windstorm in Kuwait City, 7 March 1997. In 1999, I founded a public intercessory prayer [Ministry](#), still on-going today.

The catalyst for public involvement in this societal conflict between Christian and [homosexual](#) worldviews occurred in December 2000, when my 16 year-old daughter, who was attending Central Memorial High School, was told during a Guest Speaker presentation by Calgary Birth Control Association (now Calgary Sexual Health Centre) that:

“Being ‘gay’ is part of your genes you have no choice. Your only choice is whether you practice it or not.” [My daughter’s words]

These unproven assertions were unauthorized and direct challenges to her Christian beliefs and our deeply held family values. In response to written questioning, the host teacher indicated that the lecture was on the topic of Sexual Assault, the CBE had no curriculum guidance for instruction on homosexuality, and that the Guest Speaker was only giving “*her personal beliefs.*”

Consequently from January 2001 to March 2004, I researched this conflict of worldviews (Christianity versus [homosexism](#)) and wrote a book on the issue, published under the title [Pivot of Civilization or Rivet of Life? Conflicting Worldviews and Same-Sex Marriage](#). A free PDF version is available, [click here](#). Copies were sent to Premier Ralph Klein, Justice Minister Irwin Cotler, Prime Minister Paul Martin, Supreme Court Justices, and various senators and members of parliament in Spring 2004.
